National Safety Council's Interim Guidelines for First Aid Classroom Training.

Students may not attend training if they have any known contagious medical condition or illness, or signs or symptoms consistent with a contagious illness.

Individuals who are immunocompromised should not attend first aid or CPR classes at this time.

Students will have their temperature taken prior to entering the training room. Any student found to have a temperature of 100.4 degrees or higher and/or signs or symptoms consistent with a contagious illness will not be allowed to attend the training.

For CPR skills practice, the student to manikin ratio will be 1:1. Students may not share manikins.

Exam gloves must be worn at all times for skills practice.
